Report

on the implementation of the Action Plan for the years 2020-2021 on the operationalization of the Integrated Law Enforcement Training Center of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs approved by Annex no. 4 to the GD no. 429/2020

In accordance with the provisions of the Action Plan for the years 2020-2021 on the operationalization of the Integrated Law Enforcement Training Center of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs, approved by Annex no. 4 to GD no. 429/2020, in 2020 the following were achieved:

1.1. Elaboration of documents for organization, planning, development and record of training.

The order of the rector of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs no. 106 of 22.12.2020 has approved the Regulation on the organization and functioning of the "Integrated Training Center for Law Enforcement" (CIPAL) Department of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs.

On December 17, 2020, at the meeting of the Senate of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs, through the minutes no. 3 were approved 15 continuous training programs developed by the "CIPAL" Department and subsequently approved by the rector of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs.

At the same time, at the meeting of the Senate of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs, through the minutes no. 3 a new training program was approved for the training of all junior non-commissioned officers / soldiers employed within the subdivisions of the Ministry of Internal Affairs "Initial training program for non-commissioned officers/soldiers within the Ministry of Internal Affairs", which needs further approval by the Minister of Internal Affairs and coordination by the Minister of Education, culture and research.

1.2. Organizing and carrying out the training of the personnel provided for in the means of verification related to the budget support of the European Union (200 students of the Police and the General Inspectorate of Carabinieri - graduates of initial training courses; 400 employees of the structures of the Ministry of Internal Affairs - graduates of continuous training).

During 2020, 4 initial training courses were organized, during which 373 non-commissioned police officers and carabinieri soldiers were trained.

2.1. Design of the Center's buildings and related infrastructure (Chisinau mun., Sfanta Vineri str., no.7).

The "Stefan cel Mare" Academy of the MIA has purchased the Services for elaboration of the project documentation for the reconstruction of the interior urban systems of the objectives of the "Stefan cel Mare" Academy of the MIA, Chisinau mun. Sf. Vineri str., no. 7. Economic operator "Baucom Grup" LLC.

2.2. Capital repair of buildings, construction of infrastructure, installation of communications and arrangement of the territory of the Center (Chisinau mun. Sf. Vineri str., no. 7)

Report

Regarding the implementation of the Action 1.3. "Improving initial and continuing training capabilities, with a focus on human rights, modern management and anti-corruption techniques" of the Budget Support for Police Reform

Performance criterion for 2020 - CIPAL fully operational of components 2, 3, 4a, 4b, 4c, 5a, 5b, 6, 8a and 8b (corresponding to study rooms, training rooms, auditoriums, bedrooms and hygiene facilities); with two 16-week initial training courses for non-commissioned officers (minimum 250 participants) and at least 15 continuing education courses (minimum 450 trained participants).

In order to achieve the fully operational performance criterion for CIPAL of components 2, 3, 4a, 4b, 4c, 5a, 5b, 6, 8a and 8b (corresponding to the study rooms, training rooms, auditoriums, bedrooms and hygiene facilities) the following actions have been performed:

- **1.** On 11.01.2020, the Minister of Internal Affairs sent a letter no. 44 / 30-86 addressed to the Prime Minister of the Republic of Moldova requesting:
- 1) Further maintenance of the location of the Integrated Training Center for Law Enforcement of the Ministry of Internal Affairs at: mun. Chisinau, str. Nicolae Dimo, 30, established by GD no. 35/2018 and holding discussions with development partners, in order to identify sufficient financial sources for the development of the infrastructure provided for by the project implemented.
- 2) Dislocation of the Integrated Training Center for Law Enforcement of the Ministry of Internal Affairs in the building of the Academy "Stefan cel Mare" of the Ministry of Internal Affairs, located on 7 Sf. Vineri Street, Chisinau and its operationalization according to EU standards, at the expense of 60.0 million MDL provided by the Law on Budget for 2020.
- 3) Transfer of the Integrated Training Center for Law Enforcement of the Ministry of Internal Affairs to the "Ştefan cel Mare" Academy of the Ministry of Internal Affairs, according to the Government Action Plan for 2020-2023, approved by GD no. 636/2019, chapter II, point 2.1 "Improving the system of initial and continuous training of police officers, with an emphasis on practical training; unification of the training system at the MIA level under the umbrella of the "Ştefan cel Mare" Academy of the MIA".
- 4) Carrying out a working meeting with the representatives of the Delegation of the European Union in the Republic of Moldova where the above-mentioned actions will be discussed and the subsequent information of the Delegation of the European Union in the Republic of Moldova, regarding the adopted decision.
- 5) Modification of GD no. 53/2018 and of the Action Plan for the years 2018-2021 regarding the establishment of the Integrated Training Center for Law Enforcement of the Ministry of Internal Affairs, in order to adjust the established requirements, as well as the proposed deadlines for implementation.

On 16.03.2020, the answer was received to letter no. 44/30-86 addressed to the Prime Minister of the Republic of Moldova, in which the following are mentioned:

1. In order to rationally manage the budget support, as well as to avoid increasing the state budget expenditures, it is considered inappropriate to develop the

CIPAL infrastructure on the land at the address 30 Nicolae Dimo Street, Chisinau. Respectively, it is necessary to amend GD no. 35/2018 "On the construction of the Integrated Law Enforcement Training Center".

- 2. We support the idea of creating, fortifying, developing and concentrating in a location the infrastructure necessary for the activity of the Center in the complex of the "Ştefan cel Mare" Academy at the address str. Sf. Vineri, no. 7, Chisinau mun. (including tactical training ground). It is therefore proposed to revise the GD. No. 53 of 17.01.2018 "On the Integrated Training Center for Law Enforcement of the Ministry of Internal Affairs".
- 3. At the same time, at the subsequent rectification of the Law on State Budget for 2020, proposals will be submitted in order to complete Annex no. 6 with a new capital investment project "Reconstruction of the complex of the Integrated Training Center for Law Enforcement, str. Sf. Vineri, no. 7, mun. Chisinau".

Law no. 61/2020 on amending the Law on State Budget for 2020 no. 172/2019 (*Annex no. 6*) modifies the destination/location of the financial means destined for the operationalization of the Integrated Training Center for Law Enforcement of the Ministry of Internal Affairs (*hereinafter* CIPAL) from the address of Chisinau mun., 30 Nicolae Dimo Street, land with cadastral no. 01003131013, to the address Chisinau mun., Sf. Vineri str., no. 7, land with cadastral no. 0100218669, under the management of the "Ștefan cel Mare" Academy of the Ministry of Internal Affairs.

- **2.** Letters of clarification were sent to the Agency for Geology and Mineral Resources and the City Hall of Chisinau to comment on the geotechnical condition of the land with cadastral no. 01003131013 on Nicolae Dimo str., no. 30 and the risks that may occur as a result of construction works on the surface of an unfavorable land (Being attached also the Technical Report Object no. 007- GI/2017 regarding the execution of geotechnical prospecting works).
- 1) The response was received from the Agency for Geology and Mineral Resources no. 80/05 of 30.01.2020, where it was mentioned that, following the analysis of the latest researches on the territory of Chisinau, which were carried out in 2019, by the State Enterprise "Hydrogeological Expedition in Moldova", the land with cadastral number 01003131013 on Nicolae Dimo str., no. 30, is located on the edge of an ancient landslide fracture and is affected by the development of two ravines and any earthworks on this sector that will involve extensive morphological changes may even lead to the activation of landslides of ancient land.
- 2) At the same time, the response was received from the General Directorate of Architecture, Urbanism and Land Relations, no. 21/268 p of 21.02.2020, which mentions that, according to the materials analyzed based on the engineering-geological and hydrogeological conditions, the chosen land has unfavorable conditions for construction, as well as the fact that it is necessary to exclude the execution of works involving earthworks and deforestation of the existing slopes and trees.
- **3.** In order to exclude the performance of works that involve earthworks and the deforestation of existing slopes and trees, the MIA Order no. 235/2020 "On some

measures to implement the Agreement on the financing of the European Union CRIS:ENI/2015/038-144" Support for Police Reform",m by which it was established:

- 1) To develop on the territory located at Chisinau mun., Sf. Vineri str. no. 7, the infrastructure of the Integrated Law Enforcement Training Center of the Ministry of Internal Affairs, administrative block, study rooms, hotel/dormitory for students, self-service canteen and space for food preparation, sports fields, gyms and wrestling.
- 2) To initiate the procedure of reconstruction, construction and landscaping of the territory, located at Chisinau mun., Nicolae Dimo str., no. 30, the hotel, tactical training grounds of the Integrated Law Enforcement Training Center of the Ministry of Internal Affairs, consisting of light constructions, where practical meetings will be held in the field of professional intervention, instruction for maintaining, ensuring and restoring public order, as well as obstacle training tracks.
- **4.** The order of the Ministry of Internal Affairs no. 286/2020 has approved the Concept on the operationalization of the Integrated Law Enforcement Training Center of the MIA and the Action Plan on the operationalization of the Integrated Law Enforcement Training Center for the years 2020 2021 on the territory of St. Friday str., no. 7.
- **5.** On 24.06.2020, during the Government meeting, the Government Decision no. 429 was approved on the organization and functioning of public educational institutions subordinated to the Ministry of Internal Affairs. Annex no. 4 provides for the Action Plan for the years 2020-2021 on the operationalization of the Integrated Law Enforcement Training Center of the "Stefan cel Mare" Academy of the Ministry of Internal Affairs.
